TEST COMMENTS:

A drought that began in Sept of 2023 left little subsoil moisture as planting drew near. Brian tracked rainfall for 2024: 3.13" in April, 5.03" in May, 12.32" in June, 4.45" in July, 5.26" in August, and 0.82" in September. Warm/dry weather in September and October brought corn to maturity very quickly. Brian found that the sidedress of N paid off in this plot and his farm, as the excessive summer rains leached earlier N applications from corn roots. Hybrids in this plot stood very well at harvest, despite most experiencing premature death due to lack of moisture. Disease pressure was not an issue here. Rust did show up late, but was not a yield deterrent.

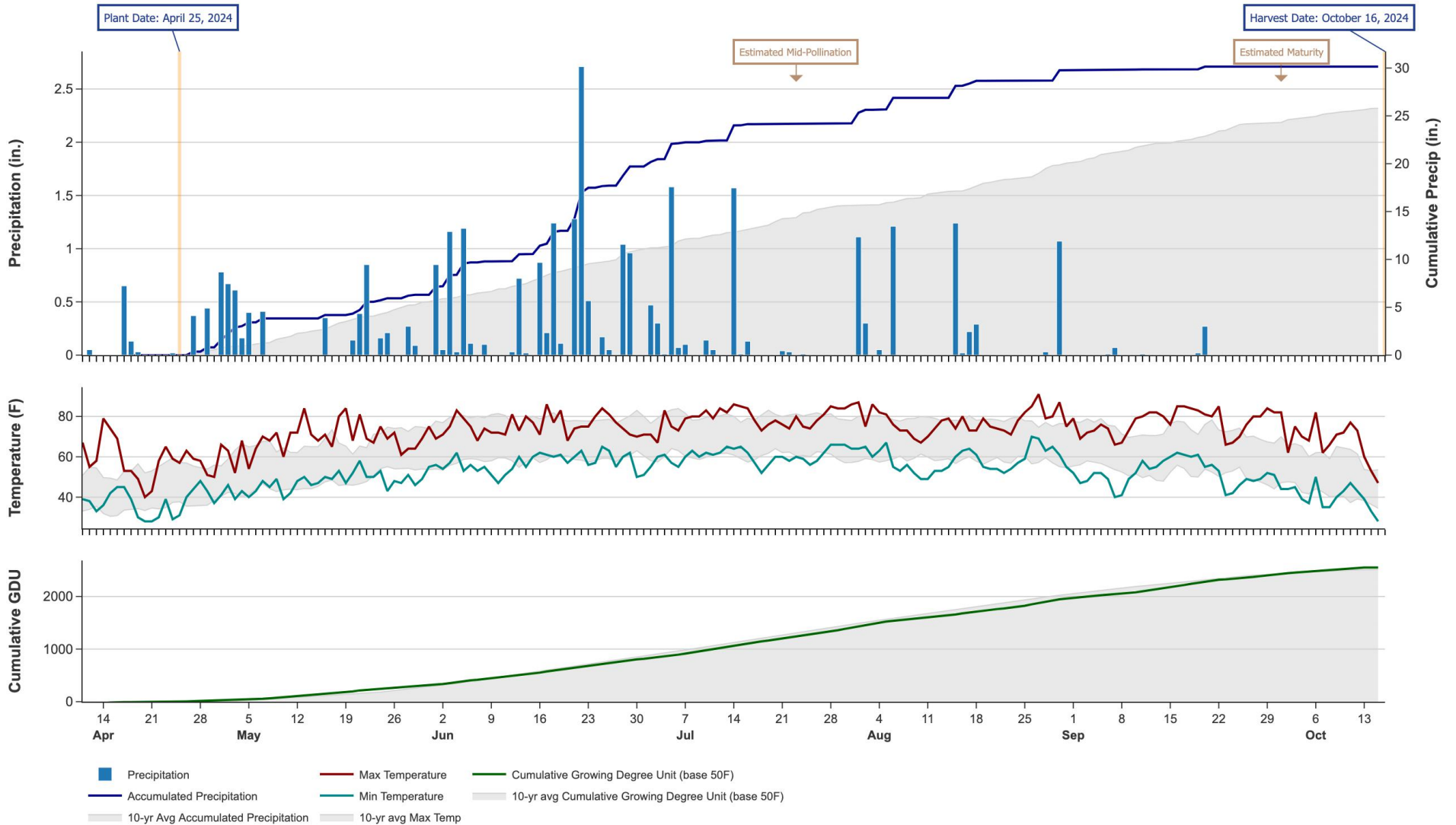
